#### **5443 DECLARATION ON INTERESTS**

Councillors declared interests on agenda matters and reminded that any change in interests must be notified to the clerk within 28 days.

Cllr. G. Curwen, Cllr. P. McWhirter and Cllr. J. Savage declared their interests as members of Pilling Village Hall Committee.

## **5444 MINUTES OF THE PREVIOUS MEETING**

Resolved: The minutes of the meeting held on 8<sup>th</sup> May 2024 having been circulated, were agreed and signed by the Chairman as a true record.

# **5445 PUBLIC PARTICIPATION**

Resolved: Standing Orders were suspended to allow residents to speak.

# Wyre Councillor Adam Leigh

Report received: <u>Create Homes -</u> Works are due to begin in July and residents have been informed via letter. <u>Glenfield Caravan Park - Discharge</u> of conditions and the siting of the bus stops not being in the most appropriate location particularly causing issue to road users leaving Carr Lane and Glenfield Caravan Park potentially causing accidents. I am assured that the road markings will improve the safety but does rely on road users being aware of buses. Highways assessment has not been submitted and planning have assured me this will be submitted prior to any decision. <u>Rabbits - Increase</u> in dead rabbits reported to wildlife investigation team who have said there is no evidence to suggest that it is due to pesticides or biocides or any evidence of foul play. From the evidence submitted and the lack of obvious injuries, it is being treated as myxomatosis.



Councillors referred to the recent sad passing of Andrew Bell, a former Parish Councillor, whose funeral was held today.

Resolved: The Parish Council meeting and Standing Orders were resumed.

## **5446 APPOINTMENT OF CLERK**

Personnel Committee met on 28<sup>th</sup> May and appointed Julia Brewer as the new clerk commencing 1<sup>st</sup> July 2024. She will work alongside the present clerk for one month, when the present clerk retires.

Resoled: The Parish Council resolved the appointment of the new clerk.

Please note confirmation of vehicle tax paid on the sit-on mower on 17<sup>th</sup> April 2024 for 12 months. There is no charge.

#### **5449 BROADFLEET SENSORY GARDEN**

Harrison Drury solicitors have conducted further searches into the land offered to Pilling Parish Council located on School Lane by Mill Bridge. This has revealed the area is registered to Crown Estates, under the Duke of Lancaster. It was considered this may only be the mining rights, but the Parish Council will not be pursuing registering the land as it was not considered commensurate with public money.

**Resolved:** The Parish Council will not pursue land ownership but maintain the Broadfleet Sensory Garden laid out in 2011 and continue to include community members.

# **Pilling in Bloom**

Cllr. Mrs. J. Judkins reported squirrels have been seen in the Broadfleet Sensory Garden, those being the youngest members of the Scout Movement! Working to clear weeds and plant annuals to brighten the area. Yellow Rattle was planted on Back Sands Lane to restrict the grass. Pilling information map is almost complete and will be erected soon.

# Report of the representative on Pilling Village Hall

Cllr. P. McWhirter reported on fundraising or the all-inclusive play equipment and to use one of the grassed football pitches to hold the Multi Use Games Area. Next event will be the football and on 6<sup>th</sup> and 7<sup>th</sup> July the Vintage Weekend. During the D-Day Party a visitor complemented the facilities at Pilling Village Hall as being the finest in the area.

# **Pilling Community Action**

Cllr. Mrs. J. Judkins reported on the newly formed Walking Group there are to be 4 wildlife walks with a guide to highlight what is in our local vicinity. Costs of produced Pilling Walks are being sourced. The walks will attract visitors to Pilling who in turn will spend. The Sing-Up Group is taking a hiatus for the present as a singing leader is sourced.

# **Our Future Coast Working Group**

Cllr. A. Whiteside and Cllr. S. Phillpotts have met with the project team to discuss their proposals and their effect on Pilling and surrounding landowners and their findings were presented to the Parish Council including a slide show. The 'lagoon' is now defined as water catchment areas on individual farms and farmers will receive payment for holding back the water. The Environment Agency and Lancashire County Council are investigating permits for water course clearing up to the sea wall. Working with Natural England and the Marine Management Organisation they are investigating marsh dredging.

When Wyre's Our Future Coast project manager saw the marsh she commented on the serious lack of sea plants and flowers as there is not sufficient water to grow them She suggested to create a delta, allowing more water to exit and cultivating the flora and fauna, to be presented to Natural England with Our Future Coast standing the cost. The Environment Agency acknowledges the outfall doors should be side hung allowing for more water, as with the River Cocker, with a crank system to close if necessary. Broadfleet Bridge flood gates are to remain and will be permanently open.

It was noted that thanks to these lead Councillors it is the first time Pilling Parish Council has got listened to at principal authorities and identified potential problems and were thanked and hoped further positive steps will occur in Pilling.
